Pantheon International Participations PLC Performance Update at 30th April 2015

Pantheon International Participations PLC ("PIP") announces an unaudited net asset value ("NAV") per share at 30th April 2015 of 1,533.7p, a decrease of 44.7p (2.83%) from the NAV per share as at 31st March 2015. Foreign exchange losses (-40.7p, -2.58%), valuation losses (-4.2p, -0.27%) and expenses and taxes* (-1.9p, -0.12%) were partly offset by investment income (1.7p, 0.11%) and share buybacks (0.4p, 0.03%).

PIP's valuation policy for private equity funds is based on the latest valuations reported by the managers of the funds in which PIP has holdings. In the case of PIP's valuation at 30th April 2015, the majority of reported valuations (accounting for circa 95% by value) are dated 31st December 2014.

At 30th April 2015, PIP's private equity assets stood at £861m, whilst cash balances were £143m. Undrawn commitments to investments stood at £247m at 30th April 2015, calculated using exchange rates at that date. In addition, the Company's multi-currency revolving credit facility agreement, comprising a US\$100m facility and a €46m facility, remained completely undrawn.

PIP's portfolio generated net cash of £16.0m during the month, with distributions of £19.7m relative to £3.7m of calls from existing commitments to private equity funds.

PIP made a primary commitment of £3.1m to a US growth equity fund during the month.

PIP also invested £1.3m in share buybacks, acquiring 100,000 ordinary shares at a price of 1,303p. This price represented an average discount of

17% to the NAV per share as at 31st March 2015.
